

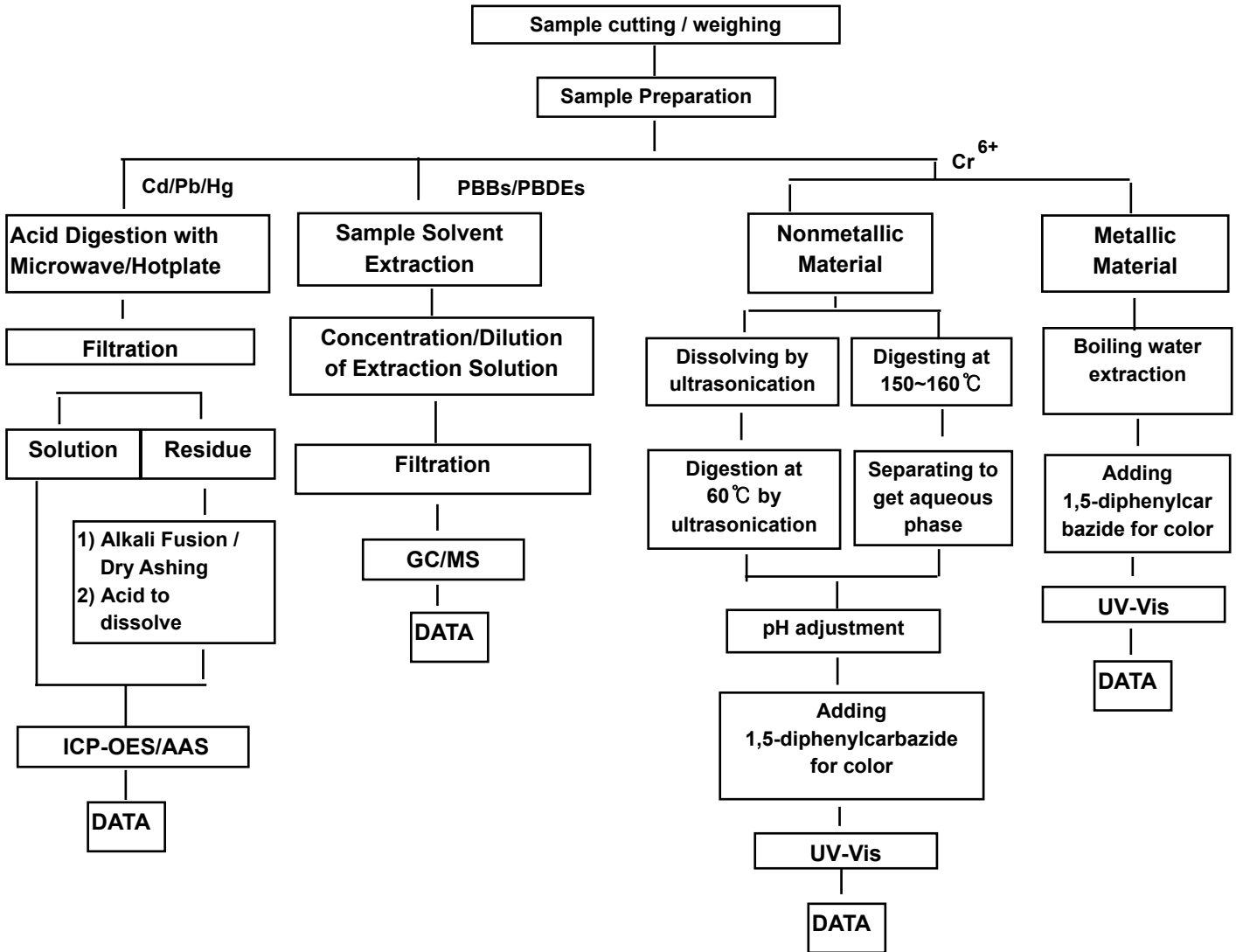

Testing Flow Chart for RoHS: Cd/Pb/Hg/Cr<sup>6+</sup> /PBBs&PBDEs Testing

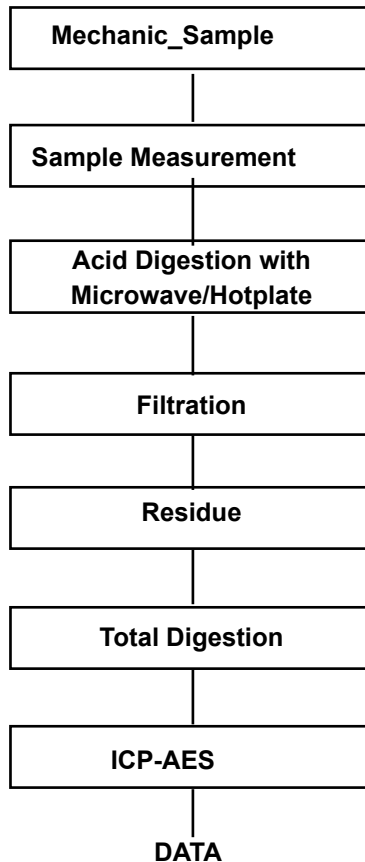

### Flow Chart for Inorganic Elements Testing

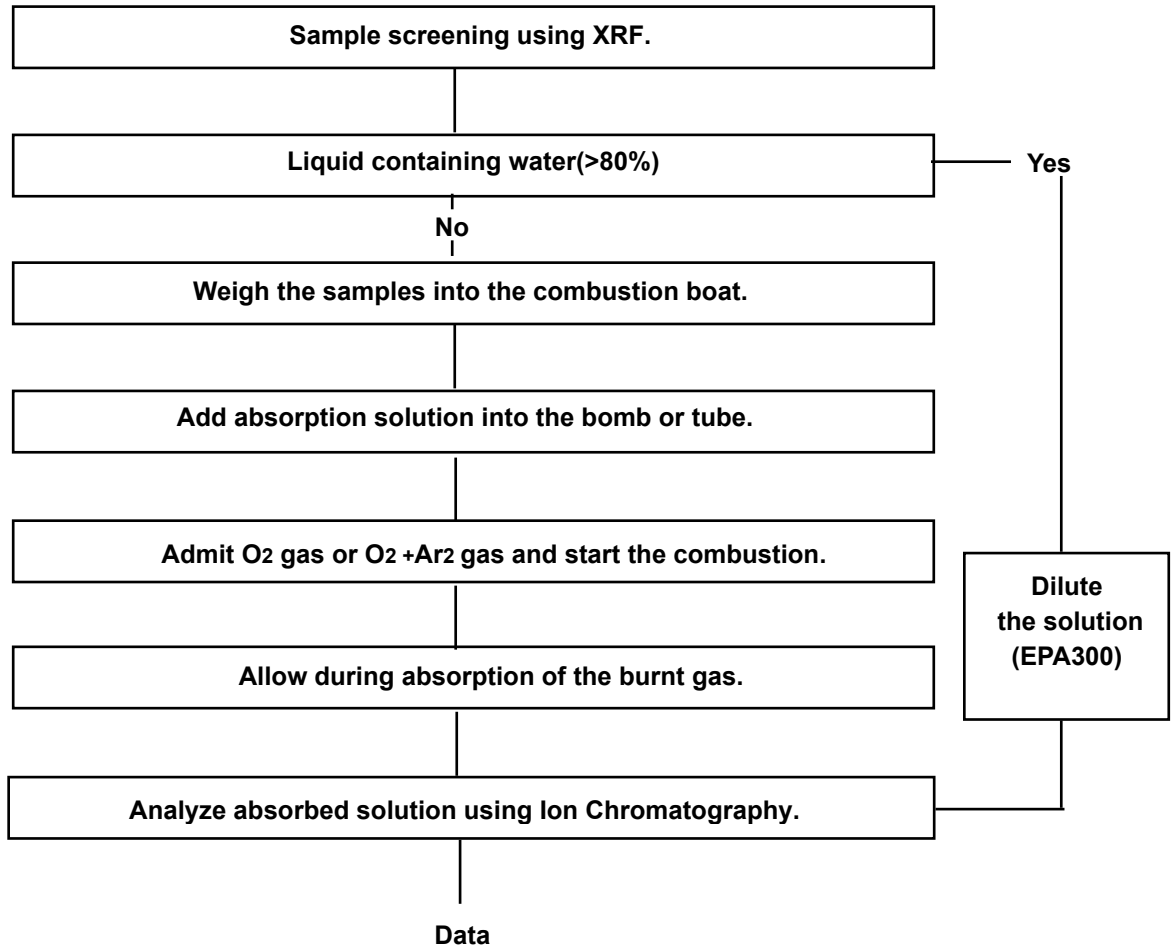

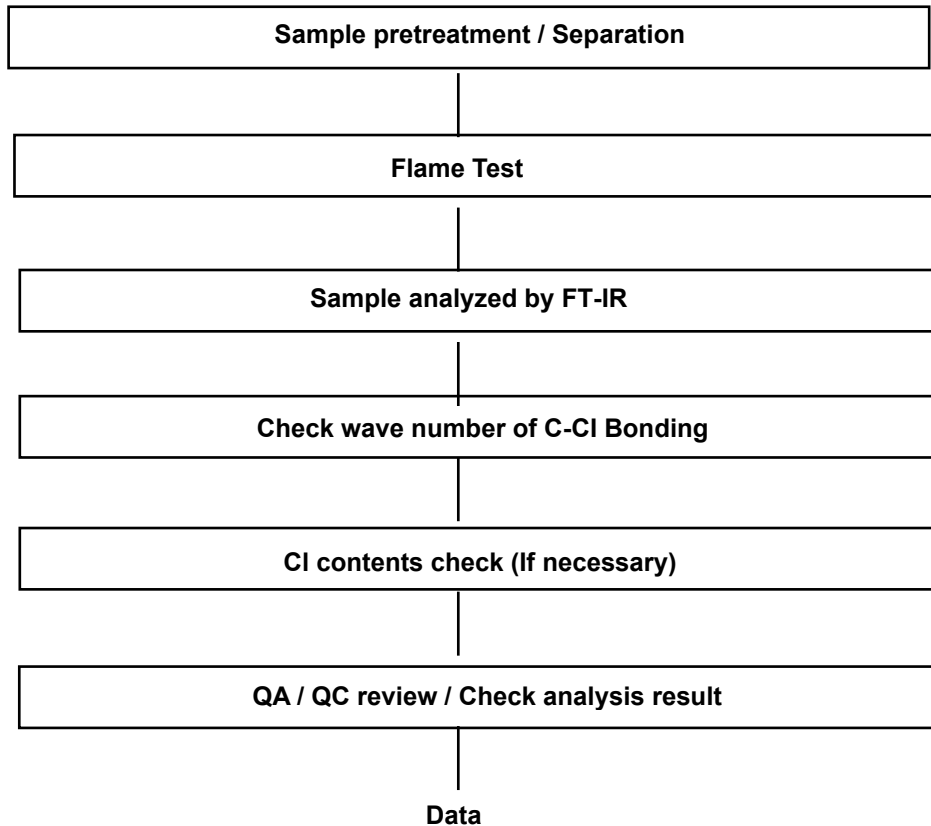

### Flow Chart for Halogen Test



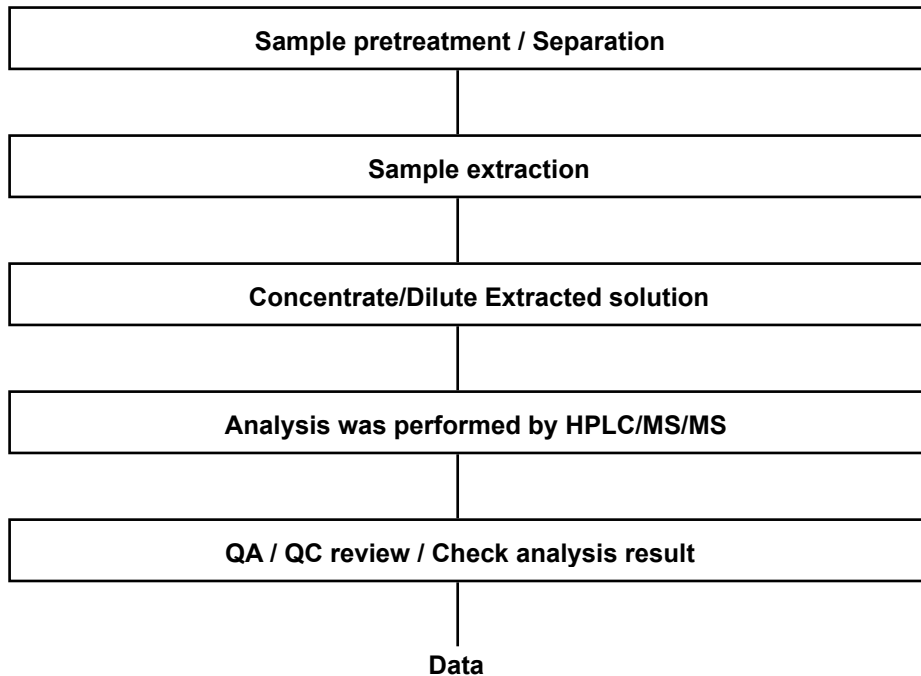

### Flow Chart for PVC Test



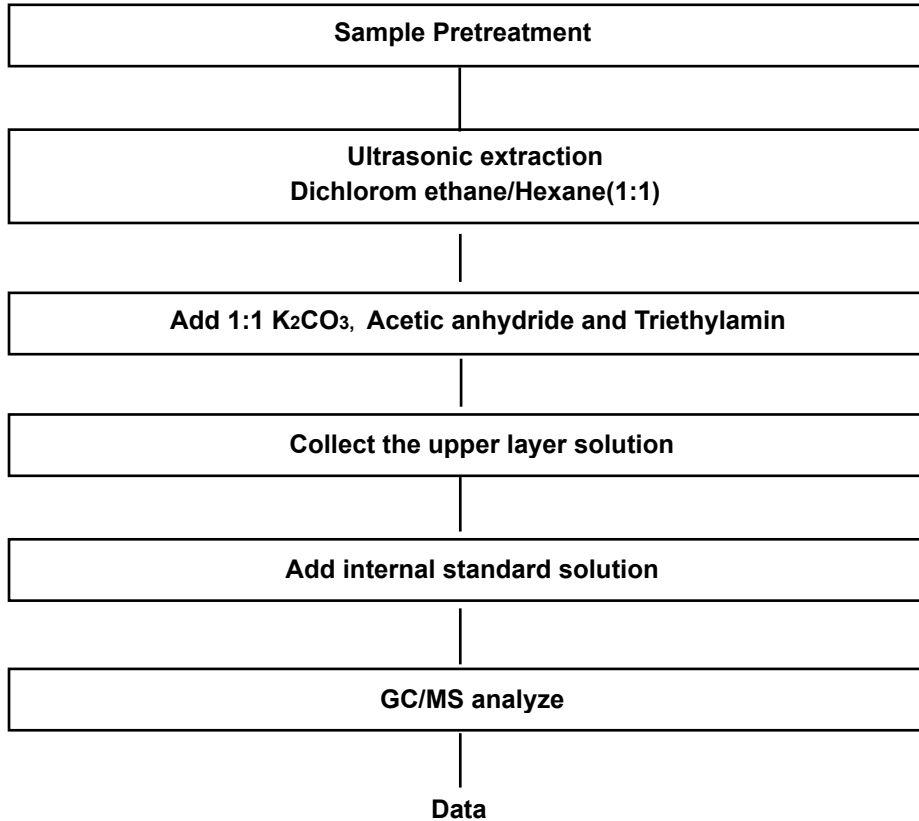

### Flow Chart for PFOS/PFOA Test



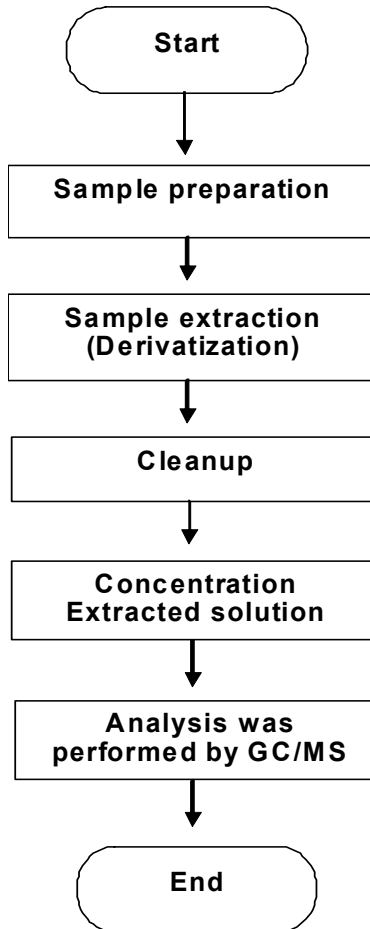

### Flow Chart for TBBPA Test



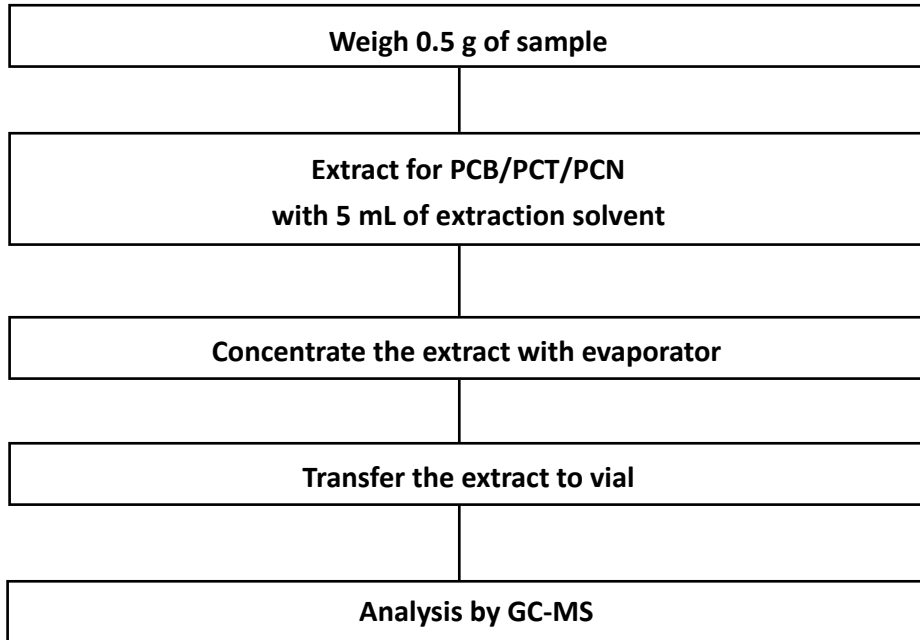

**Organotin Flow Chart**



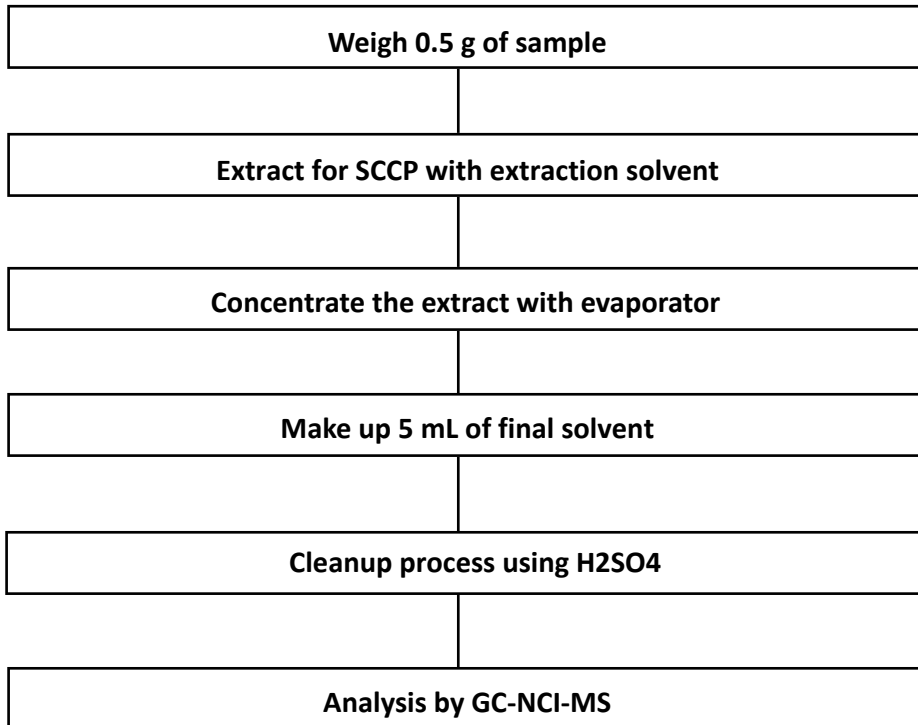

### Flow Chart for (PCB/PCT/PCN)



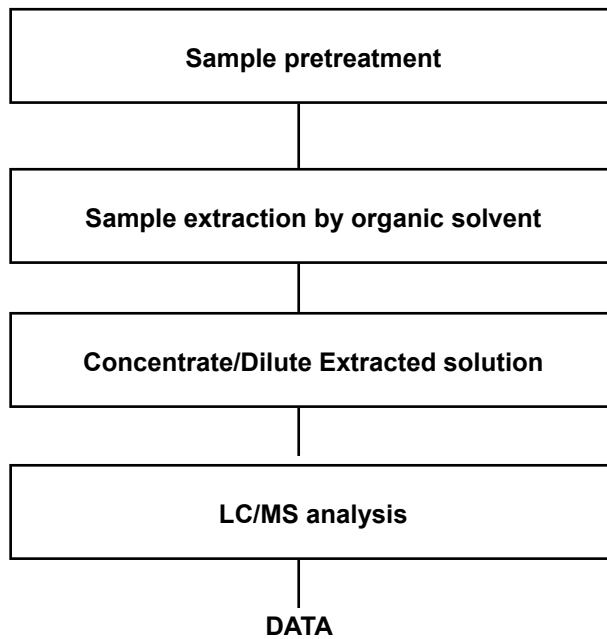

**Flow Chart for SCCP**



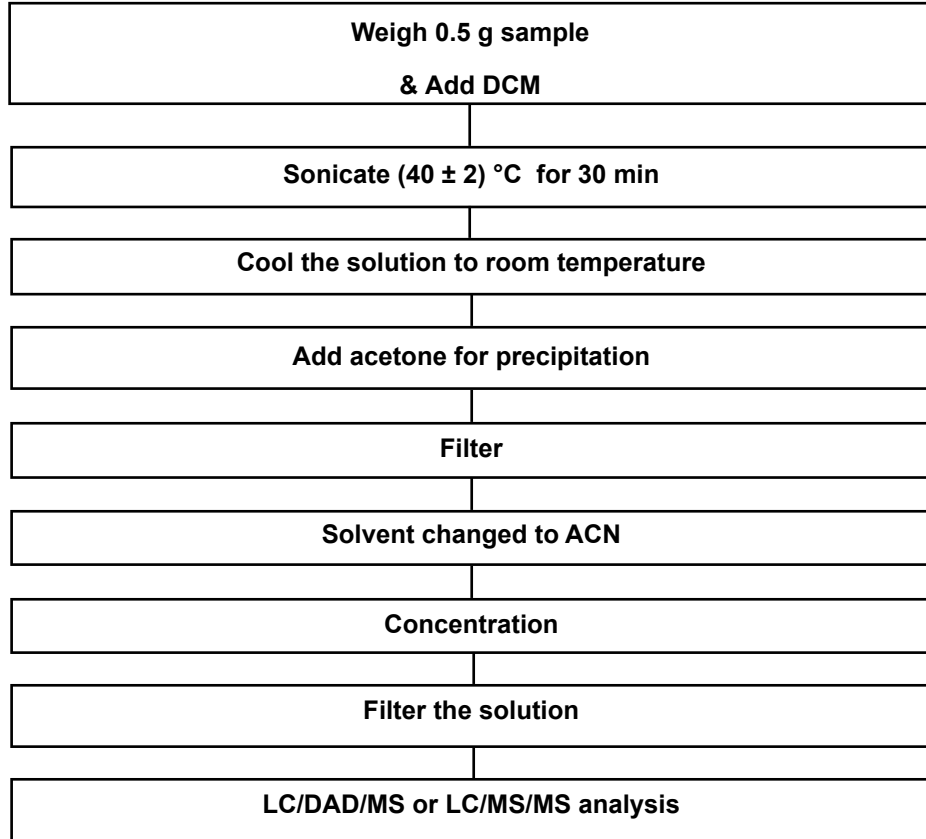
